# • Annual Diocesan Appeal May 2016 Report

# 1. \*\* APPEAL UPDATE:

Thank you to Fr. Pier Pandolfo and to the parishioners of St. Joseph's Parish, Smithers for reaching their goal. As of last week, St. Joseph's Parish reached 101.7% of their parish goal. There are five parishes that have met and exceeded their goal. Please keep in mind, we only need 7.3% to reach our Diocesan Goal. We continue to encourage parishioners to support the Annual Diocesan Appeal in any way that they can.

The Appeal Director and the Appeal Committee would like to remind parishes that any amount raised beyond the parish goal will be returned 100% to the parishes for any parish project. The first disbursement of funds was last January 2016. Upon reaching our Diocesan Goal, the funds will be disbursed accordingly from the Appeal 2015-16 allocations.

Also, a word of thanks to those who have completed the Appeal Survey which concluded Tuesday, May 24, 2016. Your responses to the survey and other suggestions will be given due consideration by the Appeal Committee. Any changes that will be implemented resulting from the survey will be communicated before the 2016-17 Annual Diocesan Appeal kick-off.

4. **BILL C-14**: Medical Assistance in Dying, passed third reading in the House of Commons yesterday, and we are continuing to urge the Senate to further protect the conscience rights for physicians and facilities in the legislation.

We are pleased to see MPs approved two suggested amendments to the Bill, affirming the protection of freedom of conscience and of religion in the Canadian Charter of Rights and Freedoms and stating that a doctor cannot be compelled to perform euthanasia or physician-assisted suicide.

While we oppose any form of assisted suicide/euthanasia, we recognize that Bill C-14 is imminent and that the inclusion of conscience rights is an important first step to protect those who object to hastening death for their patients.

With Senators acknowledging that they do not feel bound by the June 6 deadline imposed by the Supreme Court of Canada and expecting to further study the legislation, there is more time for us to engage the Senate and push for further enhancements to protect our conscience rights.

The Senate needs to be sent a clear signal that this Bill must provide clear conscience protection from coast to coast, thereby preventing a patchwork of policies and regulations from province to province.

We need a clear statement from the Senate that conscience protection extends to healthcare institutions like hospitals, nursing homes and hospice facilities. It needs to be clearly stated that conscientious objections include direct and indirect participation, such as referrals. And we remain concerned about discrimination, that a palliative care physician will be required to perform physician assisted death to get a job, whether or not they believe it is right or wrong. That is discrimination, and discrimination on the basis of personal characteristics like gender, skin colour, religious belief or creed is illegal in Canada. We urge the Senate to recognize, and address, these shortcomings in the government's legislation.

Thank you for your ongoing support for the conscience rights of Canadians.
